
# About IHACPA

- Established as the Independent Hospital Pricing Authority (IHPA) under the 2011 National Health Reform Act
- National Efficient Price (NEP) and National Efficient Cost (NEC)
  - Drives Commonwealth Government contribution of public hospital funding
- Functions:
  - Develop and refine classifications for hospital outputs
  - · Set data standards and collect data on hospital costs and activity
  - Development of pricing framework and policy
  - Safety and quality penalties
  - Develop pricing model to determine NEP and NEC annually
- Governed by the Pricing Authority chaired by Mr David Tune AO PSM
- From August 2022, expanded its role to include providing aged care pricing advice and renamed the Independent Health and Aged Care Pricing Authority









# Towards a residential aged care pricing framework

- AN-ACC as a funding model looks to fund the cost of care at the required level of output
- Developing a 'price' requires evidence and accurate activity and costing data
- Costing studies are currently being conducted throughout the country
  - Empirical studies including data collections at a representative sample of facilities to measure the resource use and costs of care
- Initial pricing advice utilised an interim methodology as AN-ACC implemented 1 October 2022





# Interim methodology

- Starting point:
  - Price weights for AN-ACC classes from the RUCS study
  - Commonwealth October 2022 starting price of \$216.80 for a price weight = 1 per bed day.
- Then update starting price to reflect:
  - Inflation
  - Wage changes
  - Policy changes
- Primary data source:
  - Aged Care Financial Report
  - Australian Bureau of Statistics wage and inflation indexes
  - Fair Work Commission Interim Decisions





# Interim methodology

Model step	Total	Cumulative percentage change
Starting price	\$216.80	
Less \$10 BDF supplement – to be paid separately	\$206.80	
Inflation and wage adjustment 2022-23	\$213.30	3.10%
FWC decision on aged care worker wage increases	\$236.06	14.10%
Superannuation Guarantee increase	\$237.01	14.60%
Indexation to 2023-24	\$243.10	17.6%





# **The Consultation Paper**

The Consultation Paper on the Pricing Framework for Australian Residential Aged Care Services 2024-25 outlines IHACPA's proposed approach for developing costing and pricing advice and focuses on a range of specific topics including topics for future consideration.

2023 consultation topics include:

- feedback on the pricing principles
- developing AN-ACC funding model classes
- costs associated with stages of care and respite care
- indexation
- recommended price adjustments & future adjustments for safety and quality
- priorities for future developments and areas of work.


### Pilot Costing Study 2021-22

# **IHACPA's work program - Support at Home**

- New Support at Home program implementation from 1 July 2025
- Program and policy design continues in 2023
- Aged Care taskforce to provide recommendations to Government by December 2023
- IHACPA's work program over the next 12 months:
  - Establishing the Support at Home work program
  - Support at Home costing study currently in the field
  - Public consultation in mid-2024 to inform final pricing advice





# Aged Care taskforce

### Will deliver recommendations to Government by December 2023:

- sustainable funding for providers
- encourage innovative care delivery approaches that meet older Australian's preferences
- aged care funding is affordable with arrangements that balance equity and fairness between older and working-aged Australians
- older Australians can see the value of their contributions relative to other funding sources
- there is a robust safety net that properly recognises financial capacity at different levels of income and/or life circumstances
- contribution arrangements are efficient, simple to implement, and easily understood by all Australians





# Aged Care taskforce

### Specifically, the Taskforce will provide advice on:

- funding and contribution approaches to support innovation in care delivery
- a fair and equitable approach to assessing the means of older people accessing residential and in-home aged care, including the scope of income and assets included in the assessment of means
- issues and trade-offs for including/excluding different service types in the new the Support at Home program
- consumer contributions for in-home aged care, and reforms that support a future transition to a single in-home aged care system
- reforms to arrangements for pricing and funding hotel and accommodation costs in residential aged care, including the phasing out of refundable accommodation deposits

# Approval of RADs and Extra Service Fee increases

### **Core functions**


- To assess applications from aged care providers who want to charge a Refundable Accommodation Deposit (RAD) above the Ministers maximum amount of \$550,000
- To assess applications from approved providers for an increase in the amount they are able to charge for Extra Services.
