Family rebates will only apply to families not receiving scholarships and bursaries provided by the School.

Family rebates only apply from Kindergarten to Year 12. Preschool students do not attract any form of government support. Preschool fees are higher compared to the Junior School fees to cover the operating costs of this program.

Full Year Tuition Fees and Levies **5%** discount on Tuition Fees.
(Paid in full by 10 February 2026)

Prompt Payment Discount **\$50** per term if payments are made by the due date.

All rebates and discounts are conditional on the Tuition Fees and Course Levies, and any applicable Other Levies and Charges, being paid by the due dates. The School reserves the right to withhold or reverse these concessions should a family's account remain in arrears.

Due Dates

Tuition Fees and Course Levies will be invoiced each term (except for Year 12 which is invoiced across the first three terms only) and are payable on the first day of each term.

Tuition Fees and Course Levies may also be paid in three instalments as outlined in each family's fee statements.

Other Levies and Charges are due and payable on the date set out in each family's fee statements.

Supplementary charges are charged through [SEQTA Engage \(Parent Lounge\)](#) and are billed individually and fall due immediately. In some cases, the cost of the activity (such as international excursions) will need to be paid prior to departure. Continued participation in these programs will be subject to a family's school fee account being maintained.

Collections Policy

The School has a staged process to collect outstanding accounts. While reasonable attempts will be made to come to a suitable payment plan for families facing genuine hardship, on-going arrears will lead to formal recovery proceedings. The cost incurred by the School for formal debt recovery proceedings will be added to the account. The School further reserves the right to reverse fee rebates, concessions, scholarships and bursaries as well as withdraw the enrolment of students should the account remain unpaid.
