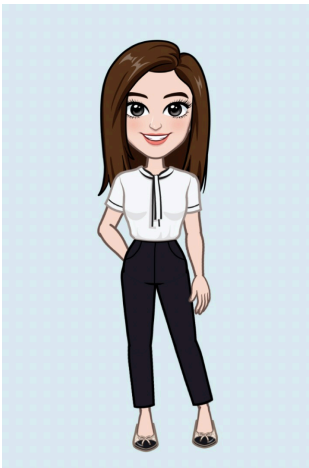


MEET YOUR BOOKKEEPER

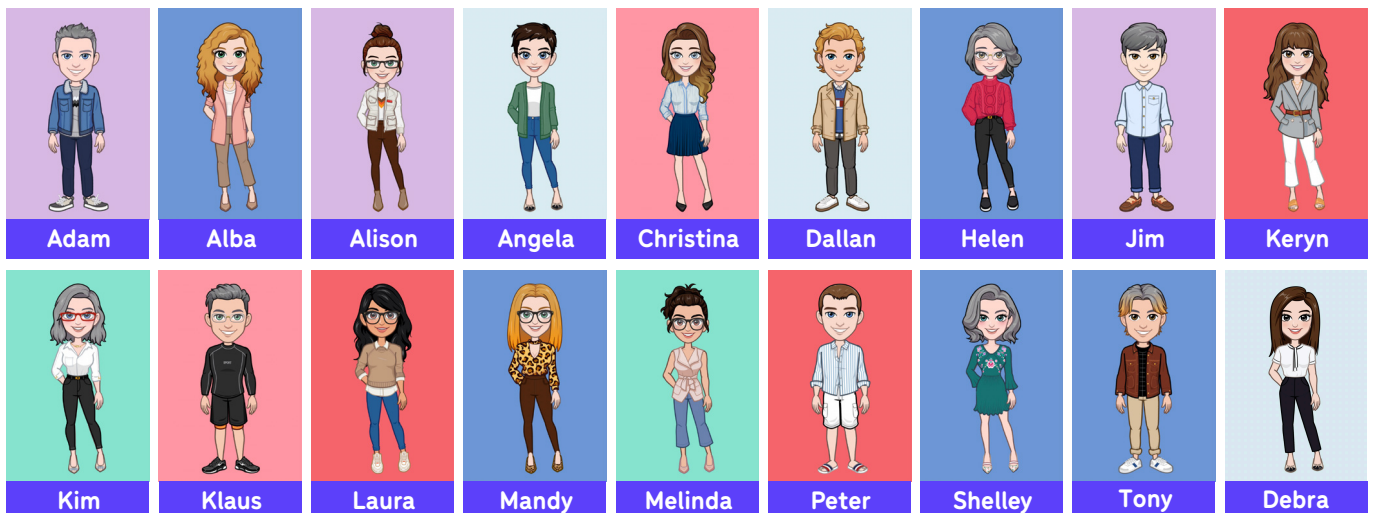
Passionate about exploring and hiking, Deb also has a strong affinity for animals and would love the opportunity to wander the great outdoors with her idol, Sir David Attenborough.
