9. Nominated Lot means a Lot nominated by us exclusively as Key Worker Lots. We may choose to vary the Nominated Lots from time to time following any release of land.

28. Key Worker Compliance Rebate

28.1 The Buyer warrants that the Buyer is actively employed as a Key Worker at the Contract Date.

28.2 The Seller agrees to pay a performance bonus of \$5,000.00 (including any applicable GST) ("Key Worker Compliance Rebate") to the Buyer, provided that:

(a) the Buyer strictly complies with the terms of this Special Condition;

(b) the Buyer is a Key Worker at the Settlement Date of the Contract;

(c) the Buyer strictly complies with the siting requirements in outlined in the Design Guidelines when constructing any improvements on the Property;

(d) the Buyer strictly complies the Design Guidelines;

(e) the house construction is completed within 12 months of the Settlement Date;

(f) all landscaping (front and rear) on the Property is completed within 12 months of the Settlement Date;

(g) all fences on the Property which are visible from the street are painted or stained;

(h) at least one tree is planted in the front yard of the Property. The tree must:

(i) be a tree species outlined in Appendix B of the Design Guidelines;

(ii) be a minimum size of 45 litres as specified in the Design Guidelines; and

(iii) meet the Design Review Panel's standards;
